Professor Li Peilin

Vice President, Chinese Academy of Social Sciences (CASS)

Professor Li is, Vice President of Chinese Academy of Social Sciences (CASS), member of the leading Party group of CASS, member of CASS Academic Divisions, member of the Presidium of the CASS Academic Divisions, Director of the Institute of Sociology at CASS, chief manager of the “Philosophy and Social Sciences Innovation Project” of CASS in the Institute of Sociology, an alternate member of the 18th CPC Central Committee. His main research fields are social development, social structure, enterprise organization and social policy. His works include *Employment and Change of the Systems*, *An Analysis of the Social Cost of State-owned Enterprises*, *Chinese Enterprises in Transition: Discussion on Organizational Innovation of SOEs*, *Growing Points of a New Social Structure*, *Transformation of China's Social Structure: A Sociological Analysis of the Reform of the Economic System*, *China in the 20th Century: Academics and Society* (200), *Building a Well-off Society in China*, *The End of Villages*, *Social Stratification in China Today* among others.

Professor Zhang Yi

Director and Professor, National Institute of Social Development, CASS

Professor Zhang Yi is a research fellow on National Institute of Social Development of Chinese Academy of Social Sciences (CASS), and director of National Institute of Social Development. He is the chief-editor of *Journal of Social Development*, and the Executive Chief Editor of *The Journal of Chinese Sociology*. In recent years, he focuses his research in the fields of class structure, population study, family sociology and so on. He published his works as below: *Clanized state-Owned Enterprises*, *Political attitude of Middle Class in Present China*, *The Research of Class Conflict Consciousness in Chinese Cities*, *The attainment of Chinese Social Status: Class Inheritance and Intergenerational Mobility*, *The attainment of Social Class Status and Education Was Affected by Family Background*, and *Population Floating and Family Risks of Migrant Workers*.

Professor Gao Yong

Professor, National Institute of Social Development, CASS

Professor Gao Yong is researcher at National Institute of Social Development, Chinese Academy of Social Sciences. Before Joining the NSDI, He has been a researcher at Beijing Academy of Social Sciences. After getting Ph.D of economic sociology in 2008, He have devoted himself to study of social stratification and social mobility. He have published several paper on influential academic journals of sociology in China, including "Mobility of Social Barriers: Inter-generational mobility in the context of structural change", "Social Justice in the Inter-generational Income Mobility: Measurement and Interpretation", et, al. He was also very concerned about the role that education played in social inequality and social mobility. His another intellectual interest is quantitative research methodology. His research articles are mainly based on survey data and statistical analysis.

Professor Yu Shaoxiang

Associate Professor, National Institute of Social Development, CASS

The research programs that Yu Shaoxiang hosted or participated include: “Research on Poverty and Crimes” (Chinese Academy of Social Sciences key topic), “Development of the Theory and Innovation of the System of Social Insurance Law”, “Research on providing legal service to the grass-roots level in villages” (Ministry of Justice P.R.C. key topics), “Research on legal profession ethics”, “Research on Law problems of Red Cross Rescue in China”, “Research on Medical System in countryside”, “China-European network dialogue on human rights” (Ministry of Foreign Affairs of the People's Republic of China's topic) and so on. His publications include five books: *I am a lawyer work for Sir Mou qizhong*, *Rights of the social disadvantaged groups - research on protection of social disadvantaged groups*, *Justices to Social Disadvantaged Groups-Study on Social Transformation and Social Law*, *Aid to Social Disadvantaged Groups-report on medical security of Chinese farmers*, and *Guardian on Social Disadvantaged Groups-Theoretical development and systematical innovation of social insurance law*, as well as about 60 articles.

Professor Zhu Tao

Associate Professor, National Social Development Institute, CASS

Professor Zhu Tao is an Associate Professor in National Institute of Social Development, Chinese Academy of Social Sciences (CASS). He got his PhD of sociology in Peking (Beijing) University, 2009. His research fields are community governance and social transformation, social development and governance, sociology of law, political sociology etc. Before joining the CASS, he was an Associate Professor of sociology in Beijing University of Technology. As a visiting scholar, he has done his research in University of California, Irvine in USA and University of Warwick in UK. He also has published many papers in The Journal of Chinese Sociology, Sociological research (Top Journal of sociology in China) etc. In these years, he has got research grants from National Social Science Foundation (China).

Professor Wu Ying

Associate Professor, National Social Development Institute, CASS

Professor Wu Ying obtained her Bachelor of Laws degree at Jilin University in 2004, and was awarded the Doctor of sociology by Peking University in 2009. Then she joined City University of Hong Kong as a Senior Research Fellow and engaged in studies of public housing in Hong Kong and grass-roots governance in mainland China. She became a member of NISD in 2011. She is the author of How the Community Is Possible? A Process Analysis of A Commercial Residential Enclave's Neighboring (in Chinese). She also published papers on Journal of Housing & the Built Environment, Journal of Social Policy, British Journal of Social Work, Habitat International, and Sociological research (Top Journal of sociology in China) etc.

Professor Ran Hao

Professor, Law Institute, CASS, Deputy Director of Social Law & Comparative Law Office

Professor Ran Hao obtained her Bachelor and Masters of Laws degrees from Nanjing University in 1997 and 2000 respectively. She was awarded Doctoral degree from The Graduate Institute, Chinese Academy of Social Sciences in 2003, majoring in civil and commercial law. She then went on to complete her Post-doc in Law from the Peking University. She then joined as an Associate Professor in Chinese Academy of Social Sciences (CASS) in 2005. She acquired the post of Deputy Director of Comparative Law office, CASS in 2007. She is presently the Associate Director of Social Law Office. She has been awarded Excellence Academic Work Award several times in her academic career. She has been a British-Academy Fellow in Oxford University, UK in 2007 a National-fund-scholar 2010 in Cambridge University, UK and Edwards Fellow in Columbia University, USA, and a Visiting Professionals Program of Landesa in Seattle USA in 2015.

Professor (Dr.) C. Raj Kumar

Founding Vice Chancellor, O.P. Jindal Global University

Director, International Institute for Higher Education Research and Capacity Building (IIHED)

Professor (Dr.) C. Raj Kumar was appointed as the Founding Vice Chancellor of JGU at the age of 34 in 2009. Professor Kumar also serves as the Founding Dean of Jindal Global Law School (JGLS) and Director of IIHED.

Professor Kumar has academic qualifications from the University of Oxford, Harvard University, University of Hong Kong, University of Delhi and University of Madras. He was a faculty member at the School of Law of City University of Hong Kong, where he taught for many years. He was a Rhodes Scholar at the University of Oxford, where he obtained his Bachelor of Civil Law degree; a Landon Gammon Fellow at the Harvard Law School, where he obtained his Master of Laws (LL.M.) degree and a James Souverine Gallo Memorial Scholar at the Harvard University. He was awarded the Doctor of Legal Science (S.J.D.) by the University of Hong Kong. He also obtained a Bachelor of Laws (LL.B.) degree from the University of Delhi, India; and a Bachelor of Commerce (B.Com.) degree from the Loyola College of the University of Madras. His areas of specialisation include, human rights and development, comparative constitutional law, terrorism and national security, corruption and governance, law and disaster management, legal education and higher education. He has over hundred and fifty publications to his credit and has published widely in peer reviewed journals and law reviews in Australia, Hong Kong, India, Japan and USA. Professor Kumar is an Attorney at Law and is admitted to the Bar Council of Delhi, India and the Bar of the State of New York.

Professor (Dr.) Tom Lairson

Professor and Advisor to the Dean, Jindal School of Liberal Arts & Humanities

Professor (Dr.) Thomas D. Lairson is Professor of Political Science at Jindal Global University and Professor Emeritus of Political Science at Rollins College. He was formerly the Gelbman Professor of International Business and Professor of Political Science at Rollins College. He received the Ph.D. in political science from the University of Kentucky. Dr. Lairson was the first Ford Foundation Professor of International Relations in 1994 at the Institute for International Relations in Hanoi and has taught at East China University of Science and Technology, Wuhan University, Fudan University and at Jindal Global University in India. He was awarded a Senior Fulbright Fellowship for Singapore in 2011. Dr. Lairson teaches courses on the political economy of Asia, with a focus on China and India. He has published articles recently on the global financial crisis, U.S.-China relations, Vietnam and China, the global economy, state capitalism in China, the strategic relationship of China and Russia, and China's Bridge and Road initiative. With David Skidmore, he is author of *International Political Economy: The Struggle for Power and Wealth in a Globalizing World*, Routledge, 2017. Professor Lairson is currently completing a book entitled "State Capitalism and Economic Growth in China."

Professor Sudarshan Ramaswamy

Dean, Jindal School of Government and Public Policy

Professor Sudarshan Ramaswamy, Dean, Jindal school of Government and Public Policy, has had distinguished careers in the domains of research, development programming and governance. After he obtained a Master's degree in Economics from the Delhi School of Economics he was elected to a Rhodes scholarship. He joined Balliol College, University of Oxford, and obtained a Master's degree in Politics in 1977. He was elected to a research fellowship at St. John's College, University of Cambridge, where he studied judicial review of economic legislation by the Supreme Court of India, specializing in the interface of law and economics. In 1984 he served in the Ford Foundation's South Asia Office in New Delhi as Assistant Representative and Program Officer for Human Rights and Social Justice. In 1991 he joined the UNDP in India as Senior Economist and Assistant Representative for Governance and Public Policy. In 2002 he was appointed Policy Advisor for Justice and Governance in the UNDP Oslo Governance Centre. In 2005, he was transferred to the UNDP Asia-Pacific Centre in Bangkok, where he was Regional Policy Advisor for Governance, Human Rights, Rule of Law, Justice, and Legal Reforms. In 2012 he joined the JGU as the founding Dean of the Jindal School of Government and Public Policy. He has an impressive track record of publications comprising books, articles, and UN policy reports, reflecting his inter-disciplinary research, teaching and policy experience in development programmes, human development, law, governance, institutions and policy.

Professor Rajeev Malhotra

Professor & Executive Director, Jindal School of Government and Public Policy

Professor Malhotra bridges the world of academics and policy making, A development economist and a civil servant with over 28 years of experience, he has worked with the Government of India, where until August 2012 he was Economic Adviser to the then Union Finance Minister. From 2002 to 2008, he worked at UN Office of the High Commissioner for Human Rights in Geneva and prior to that at the Planning Commission, New Delhi. Over the years, he has been a consultant to several international organisations. He has expertise in macroeconomic issues in development policy; fiscal policy and budgeting; planning, monitoring, evaluation and impact assessments; poverty estimation and human development; and human rights and development. He has led research on human rights and rights sensitive development indicators at the UN and is recognised as an international expert on that subject. He also worked on conceptual and operational framework for the right to development and human rights-based approaches. He has published widely. His most recent publications include *India Public Policy Report 2014* (Oxford University Press, 2014); 'India @ 100: Giving wings to the lumbering elephant', *Futures: Journal of Policy, Planning and Futures Studies*, Elsevier 56 (2014) 8-21; and *A Critical Decade-Policies for India's Development* (Oxford University Press, 2012). His research interests includes macroeconomic issues in development policy related to India and other developing economies. Human rights and development, in particular issues related to identification and operationalization of human development, human rights and good governance indicators for use in policy articulation, monitoring and evaluation of development process.

Professor Wenjuan Zhang

Associate Professor and Assistant Dean Jindal Global Law School

Wenjuan Zhang is an Associate Professor and Assistant Dean for International Collaborations of the Jindal Global Law School in India. She is also leading the Center for India-China Studies at JGU. She got her LLM degree from Columbia Law School in 2014 and Juris Master Degree from Peking University Law School in 2004. She was a visiting scholar of Yale Law School in 2012 and of Columbia Law School in 2006. She has her Marc Haas fellowship with the Brennan Center for Justice of NYU School of Law in 2015 and her PILNET fellowship in 2006-2007. Before joining the JGLS, she had been a well-respected public interest lawyer in China for over nine years. She served as Vice Director of Zhicheng Public Interest Lawyers, the biggest public interest law organization in China. Ms. Zhang and her Zhicheng colleagues have played a very pioneering role in expanding legal and political space for rights-based civil society organizations in China. She had been deeply involved in the legislative process of PRC Law on Protection of Minors (Passed in 2006), the bill drafting process of Beijing Legal Aid Act (2008) and the initial drafting stage of Anti-Domestic Violence Law (Passed in 2015). She served as an expert for the UNICEF/NWCCW Project on Implementing National Program of Action for Child Development in China and an adviser on child welfare policies for the Ministry of Civil Affairs. She has published more than 50 essays and papers as well as few books in Chinese.

Dr. Arun Kaushik

Assistant Professor, Jindal School of Liberal Arts & Humanities

Professor Kaushik is an Assistant Professor at Jindal School of Liberal Arts & Humanities. Arun was a student of the European Doctorate in Law and Economics program from October 2011 until March 2015. He received his PHD from three universities (joint degree): Erasmus University Rotterdam, The Netherlands, University of Bologna, Italy and University of Hamburg, Germany. He obtained his B.A degree in Business Economics from University of Delhi in 2007. He completed his M. A degree in Economics from Jawaharlal Nehru University, Delhi in 2009 and an M.Phil. degree in Development Economics from Indira Gandhi Institute of Development Research, Mumbai in 2011. His primary research areas are intellectual property, applied microeconomic theory and political economy. He has presented his research at various important international conferences, including European Association of Law and Economics (2014) conference, Korean American Economic Association, Asian Law and Economics Conference. He has also contributed to the report of the European Union on trade secrets. During his PhD, he examined the issues related to Trade Secrecy, sometimes called an ignored facet of intellectual property law.

Professor Mohsin Raza Khan

Assistant Professor and Assistant Dean, Jindal School of International Affairs

Professor Mohsin Khan is an Assistant Professor, Assistant Director, Centre for a New South Asia (CNSA) and Assistant Dean for Student Initiatives. Mr. Khan possess a Masters in International Economics and International relations from the School of Advanced International Studies, The Johns Hopkins University, with a specialization in South Asia. He also has an MA in Global Political Economy from the University of Hull where he was a British Chevening Scholar. His undergraduate degree is in economics from the University of Delhi. Prof. Khan is a Financial Risk Manager (FRM) certified by the Global association of Risk Professionals (GARP) New York. He has worked as a banker for several years in Dubai, both in corporate lending and risk management. He was also Senior Fellow: Foreign Policy, Economics and Finance at the India Research Group in Washington DC. His interests range over issues of Development, Foreign Policy and Economics. He has in the past written dissertations and papers on Malaysian Capital Controls during the Asian Financial Crises of 1997-98, on the Historical Rise of the West Vis-à-vis the Rest and on the Theory and Conduct of War in Islamic History.

Ms. Aleksandra Mineeva

Senior Research Associate, Jindal School of International Affairs

Ms. Aleksandra is a Senior Research Associate at Jindal Global University. Originally from Russia (Siberia), since the last fourteen years Aleksandra has been interested in studying China from the lens of multi-faceted scholarships with particular focus towards cross-cultural communication. Trained as a linguist-translator from Mandarin into Russian and English, she specialised in cross-cultural communication as her Majors in a Degree (B.A. + M.A.) from Zabaikalsky Normal University (Russia) and Beijing Foreign Studies University (China). To expand her area of specialisation in gauging the impact and study of cross-cultural communication, Aleksandra has completed a 1.5 year training in French Language and Civilisation from La Sorbonne University (France). Professor Pritam Baruah

Associate Professor and Associate Dean, Jindal Global Law School

Professor Baruah was Assistant Professor of Law at the West Bengal National University of Juridical Sciences, Kolkata from 2008-2013, where he taught jurisprudence, property law, constitutional law, and political theory. Between 2010-2014 he was a teaching fellow and commonwealth doctoral scholar at University College London. Pritam was one of the founding convenors of the UCL Legal Philosophy Forum- a forum for academics to present work in progress. Pritam has also taught comparative constitutional law as a visiting professor at the University of Ottawa. Previously he practiced law in Delhi, primarily at the Supreme Court of India, in the areas of employment law, criminal law, constitutional law and administrative law. During his time at the Delhi Bar he argued matters before diverse forums including the Supreme Court of India, the Delhi High Court, and the National Consumer Disputes Redressal Commission. Pritam also worked for the Central Vigilance Commission on the Public Distribution System constituted by the Supreme Court of India, chaired by Retired Justice DP Wadhwa.

Dr. Keerty Nakray

Associate Professor, Jindal Global Law School

Dr. Keerty Nakray has a wide-range of dynamic research interests which arise from her interdisciplinary training in social sciences. She is currently Associate Professor at Jindal Global Law School in NCR Delhi, India and Visiting Fellow at the Feinstein International Center, Tufts University. Her recent co-edited book with Margaret Alston and Kerri Whittenbury is titled "Social Science Research Ethics for a Globalizing World: Interdisciplinary and Cross-Cultural Perspectives" (Routledge, New York) which examines the ethical dilemmas in studying sensitive topics such as gender based violence, child abuse, studying combatants and climate change. Dr Nakray's previous work includes another edited book "Gender Based Violence and Public Health: International Perspectives on Budgets and Policies" published by (Routledge, London) which encapsulated some of the most latest debates on the theoretical and empirical advances in the understanding of gender based violence as a public health issue in developing economies. She has published in leading journals on gender budgets, child sensitive budgets and comparative social policy. Dr. Nakray holds a PhD in Sociology and Social Policy from Queen's University Belfast, Northern Ireland. She is also currently the Book Reviews Editor of Journal of South Asian Development and she also serves on the editorial board of Journal of Gender Studies (UK) and has been appointed on the International Advisory Board of Social Policy and Society.

Professor Deepanshu Mohan

Professor Deepanshu Mohan finished his BA Economics from Fergusson College, Pune in 2011 and went to do his Masters in Economic History from London School of Economics and Political Science. With economics as his majors, he specialized in the field of economic history.
