Register to be a part of an international event, share knowledge on victim rights, victim services, and victimological research.

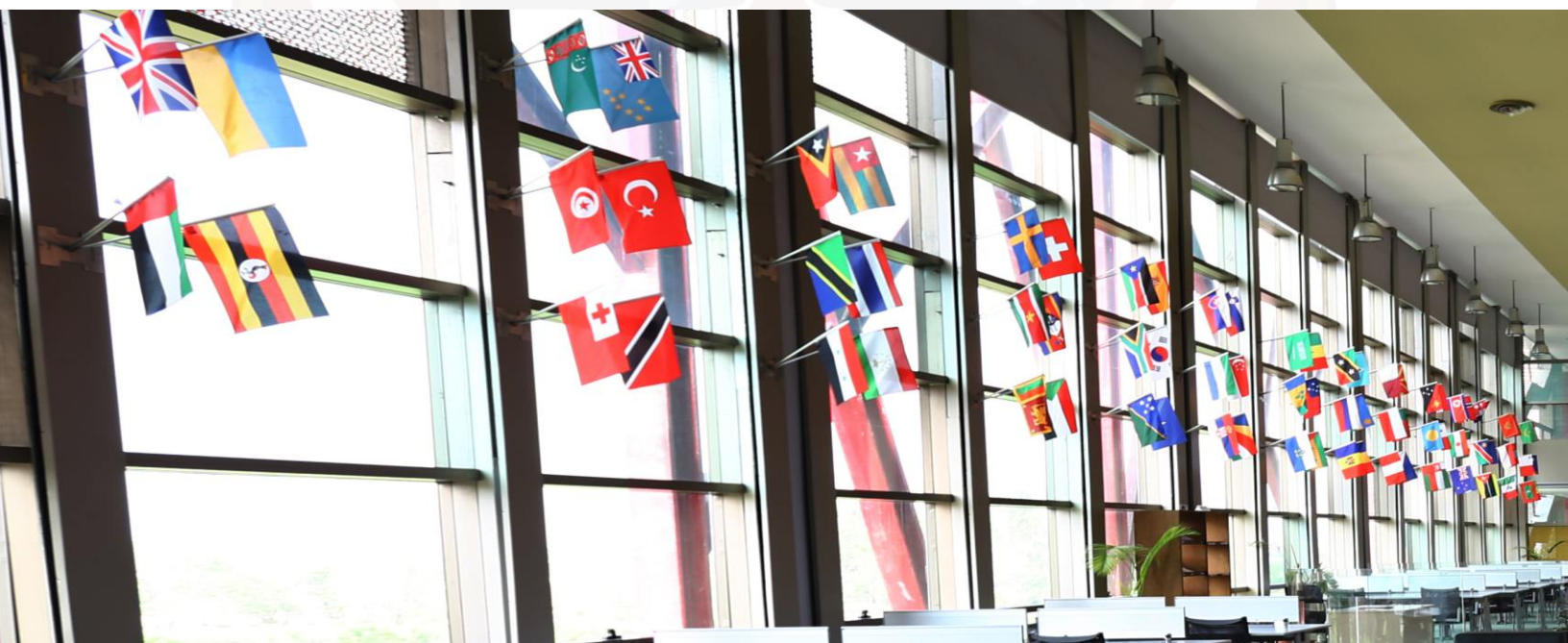
Programme Highlights

About the Centre for Women, Law and Social Change

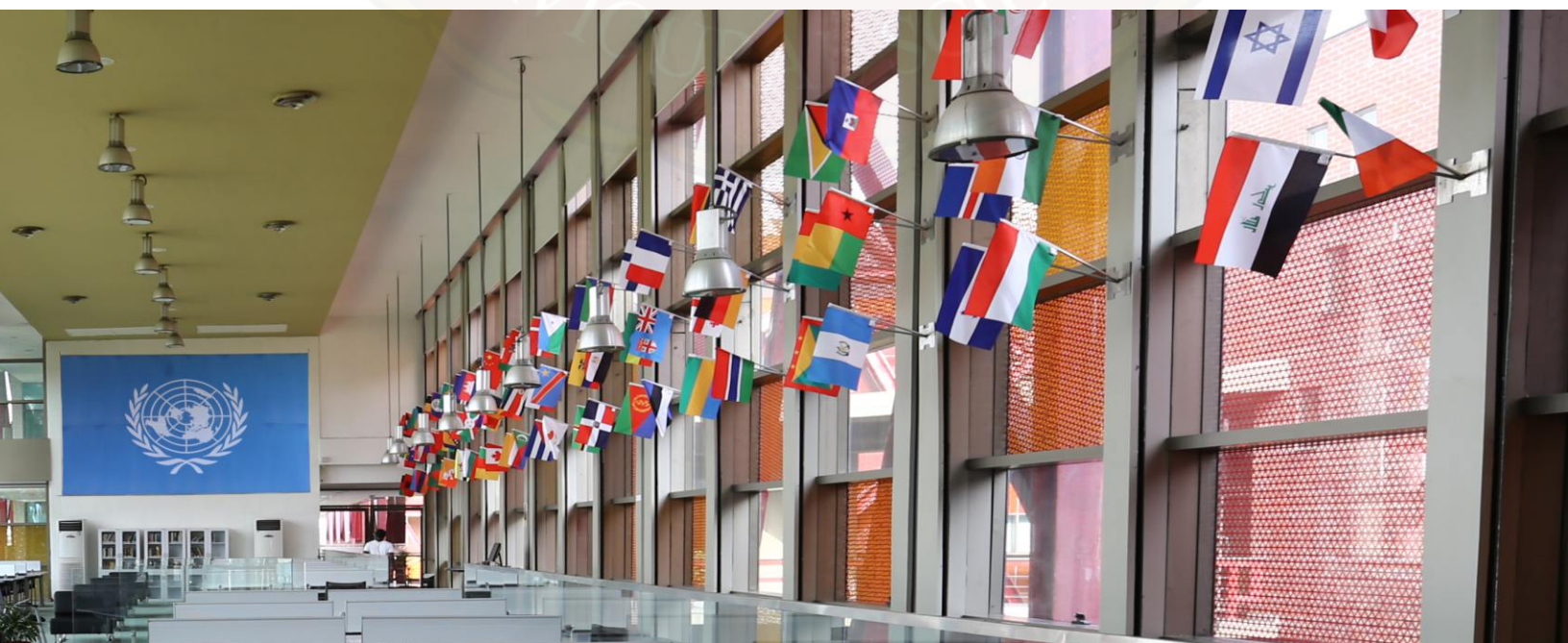

- It should be submitted in Times New Roman font, size 12 with double line spacing.
- The abstract should not exceed 200 to 250 words.

Submission

- The LAST DATE for the receipt of abstracts is Monday, 20th October 2014.
- Abstracts will be screened by a committee of experts and only those approved will be accepted.
